NOTICE INVITING QUOTATIONS

Sealed Quotations to be eventually drawn in H form duly affixing non-refundable Court Fee Stamps of Rs. 25/- (Rupees Twenty-Five) only are invited from manufacturers / suppliers / authorized dealers for Supply of Collar Steel Pipes and Accessories as detailed below and will be received in the Office of the undersigned upto 11th September 2025 and will be opened on the same day at 3 PM in the presence of the quotationers or their authorized representatives.

Detailed Quotation papers/documents may be obtained from the office of the Chief Engineer, Water Resources Department, Government Fruit Garden, Shillong- 793003 upto 10th September 2025 during office hours on payment of Rs. 100/- (Rupees One Hundred) only per set. The same may also be downloaded from the website of the Department (www.megwaterresources.gov.in) and the same be submitted to the Department alongwith a Demand Draft of Rs.100/- (Rupees One Hundred) only (non-refundable) per set.

If the date of opening of Quotation happens to be a holiday, the next working day will be reckoned as the last date of receiving and opening of the same.

Sample of the materials are also to be submitted alongwith the Quotations clearly pasting names of the firm on their bodies.

Detailed Terms and Conditions

- 1. The receipt or the Demand Draft for the cost of document is to be enclosed with the Quotation document.
- Only manufactures / Authorised dealers for the supply of the materials are eligible to cast quotations. Certified copy of dealership certificate from the manufacturer should be enclosed in case of authorized dealers.
- 3. Manufacturers / Authorised dealers may submit along with such documents technical specifications in original or duly certified / attested copies by competent authority along with <u>price list</u>.
- 4. Rate should be quoted clearly both in figures and in words. Rate should be inclusive of all taxes and charges of carriage up to different divisional godowns in the State including loading, unloading and stacking in proper places as directed by the EE / SDO / JE incharge.
- 5. Goods and Services Tax (GST) on material supplied at current prevailing rates levied by the Govt. from time to time will be recovered from the bill.
- 6. Quotationers will be guided by the general rules and directions and all clauses relevant and laid down as per H form of PWD Meghalaya and clauses of the notice inviting quotation.
- 7. Quotationers must thoroughly acquaint themselves with all the clauses of the supply/ work contract and agree to terms and conditions laid down therein.
- 8. Quotationers are to sign all pages of the document and clearly write the name of supply, name of firms, telephone No. or mobile No. on top of the envelope before casting their quotation.
- 9. Any correction in the quotation documents must be initialled by the quotationers before casting in default of which quotation shall be rejected. No application of correcting fluid will be allowed.
- 10. Rates quoted should be valid for <u>not less than 3 (three) years</u> from the date of notification of accepted rate and the selected manufacturer / authorized dealers will have to execute agreement on the prescribe PWD- H form as per rule within 15 days from the date of received of preliminary work order. (See Sl. 22)
- 11. Quotationers should submit their upto date Professional Tax and Income Tax Clearance Certificate / GST Certificate / Pan Card / Balance Sheet for the past 3 years alongwith the quotation otherwise their quotations will be summarily rejected.
- 12. Delivery of materials should be made within 30days from the date of issue of final order by the Departmental Officers on the approved rate and no extra claim will be entertained under any circumstances.
- 13. Manufacturers / Authorised dealers will be solely responsible for any loss/damage of the materials, at their own cost and risk till proper receipt are issued by the Deptt. Officer entrusted to receive the materials.
- 14. No Sub-Contract to the other firms/ Suppliers/ Authorised dealers will be allowed.
- 15. The authority does not bind itself to accept the lowest rate and reserved the right to cancel any or all quotations without assigning as reason thereof if the situation so arise with justification.
- 16. All materials supplied should be as per standard quality and I.S. specifications.
- 17. Manufacturers / Authorised dealers should submit along with Firm Certificate and Court Certified copy of power of attorney authorizing one or more of their agents to operate, sign the Quotation, receive payment etc., on their behalf. The Department's liability is to the contracting Manufacturer / Authorised dealer only and not to the person having power of attorney.
- 18. In case the materials are procured from outside the State all relevant papers should be made available to the Department officer.
- 19. Everything being equal and Department will give preference to the experienced Manufacturer / Authorised dealer and the authority deserves the right to split the supply order into two or more orders in such circumstances.
- 20. Experienced Certificate should be furnished by the Manufacturer / Authorised dealer (if available) from the officer not below the rank of Executive Engineer of Managing Director of Corporation.
- 21. Non-tribal dealers/suppliers/firms should have to furnish valid Trading license from the Autonomous District Council without which the quotations will be out rightly rejected.
- 22. Execution of PWD H form with the supplier should be done with the concerned Division and besides the Security Deposit of 10% the bill amount will be deducted from the suppliers bill by the concerned Division.

- 23. The Security Deposit will be retained by the Department for a period of 6(six) months after completion of Supply Order and the same will be released only after the E.E concerned has certified that the supply is found satisfactory and conform to standard specifications.
- 24. The Earnest money of the unsuccessful quotationers will be returned on application after finalization of the Quotations.
- 25. If the successful quotationers withdraw his/her quotation or refuse to sign the Agreement within a specified period on any pretext or condition which is not acceptable to the Department then the Department shall without prejudice to any right or remedy be at liberty to forfeit the bid as well as the S.D/ E.M.
- 26. Registration Certificate of the Manufacturers/ Authorised dealer is also to be attached with the quotation.
- 27. In selecting the quotation to be accepted the financial status / experience of the Manufacturer / Authorised dealer will be taken into consideration in addition to other relevant factors such as past experiences and capabilities.
- 28. For settlement of any dispute and of any matter whatsoever, decision of the accepting authority will be final and binding on the quotationers.
- 29. Any quotation in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
- 30. Canvassing directly or indirectly is strictly prohibited and the quotation is liable to be rejected without assigning any reasons thereof.
- 31. The detail terms and conditions as specified herein shall form part of the PWD H form agreement and the approved supplier shall have to sign all pages of the detailed terms and conditions as well as the PWD H form agreement.
- 32. All rights are reserved to reject any or all quotations by the undersigned without assigning any reasons thereof.
